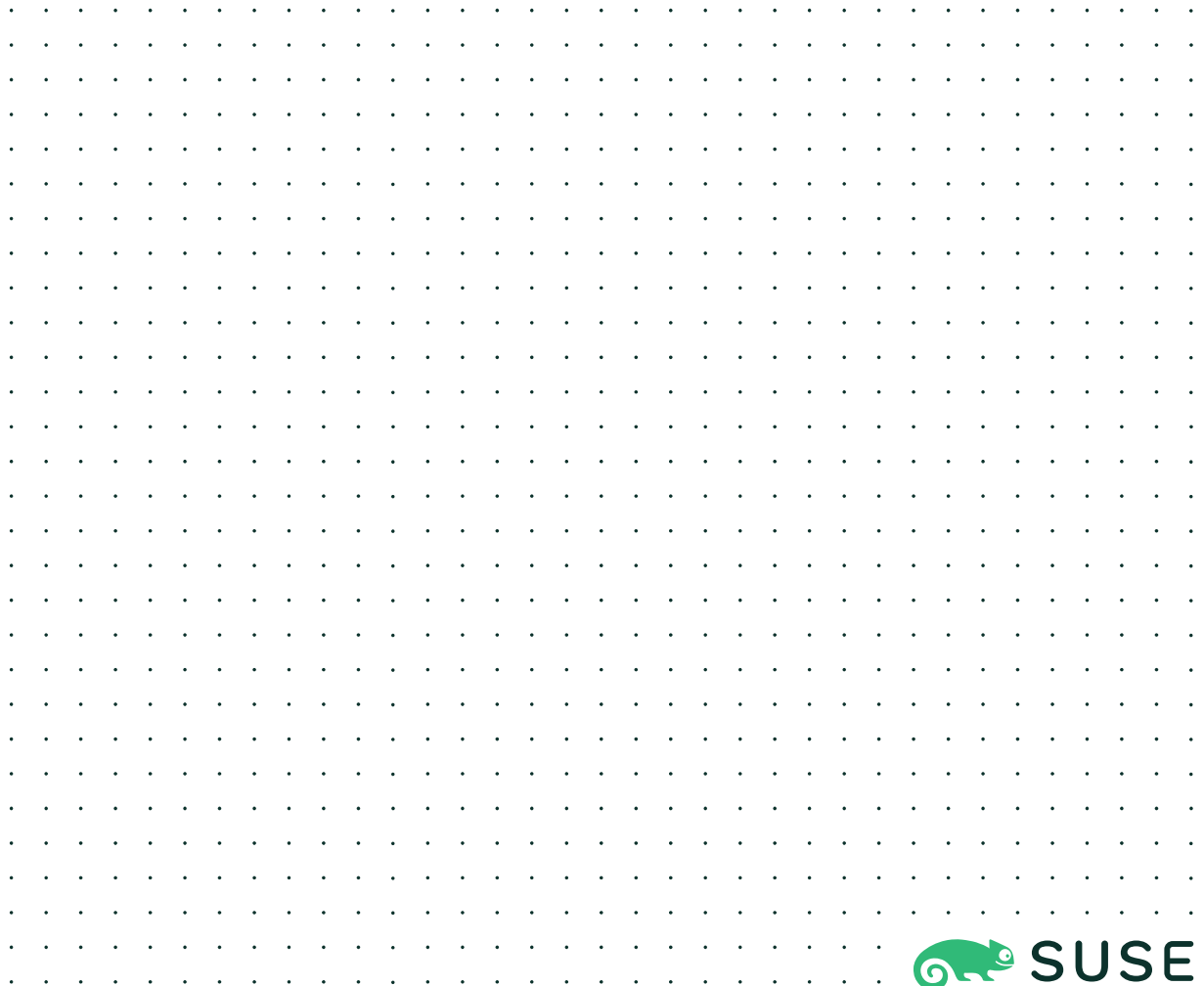

## Introduction

The VPAT is a template used to document a product's conformance with accessibility standards and guidelines.

### Evaluation Methods Used

Conformance Levels were determined using evaluation processes that include proprietary test processes, skilled accessibility testers, accessibility testing tools (namely, the Axe extension and the Orca screen reader), general product knowledge and guidance from DHS Trusted Tester Program.

## Terms

The terms used in the Conformance Level information are defined as follows:

- **Does Not Support:** The majority of product functionality does not meet the criterion.
- **Not Applicable:** The criterion is not relevant to the product.
- **Not Evaluated:** The product has not been evaluated against the criterion. This can be used only in WCAG 2.0 Level AAA.
